- Lloyd Shroyer and Todd Dawson will coordinate the emailing or sending of materials. Fortunately, our new Declaration and By-Laws allow for the emailing of Notices which will save Sunset money and time.

Manager's Report:

- The Board was provided an updated spreadsheet listing the current projects as well as those that were pending. Specific comments to that list are as follows:
 - o The electrical work is completed, and all outlets are working.
 - Bob had to reinstall a few handrails in the stairwells.
 - He has been assisting and working with the various cable companies as they provide quotes to Sunset.
 - Lloyd Shroyer asked if we can call for service on the keypad box outside of the main door. It hasn't been serviced for some time so Bob will have them come out. Lloyd was also curious if we could link cell phones to the keybox. Bob will check that out.

Landscape Committee Report

- Donna Viecili was present and provided comments to the Board.
- Todd Dawson moved to make the annual purchase of mulch for our planting beds.

- Concern was expressed over the sod near the pool area that was replaced earlier but no longer thriving. The Board asked Donna and the Landscape Committee to use her judgement and if the sod is not thriving to replace it so it will look good for the season.

Old Business:

- Advance Paver Claim –We finally received a check from Advanced for the damage caused by their trucks. Thanks to the work of our counsel we received the full amount requested.
- TV/Internet: We received three quotes from tv and/or internet and the Board was
 provided with a spreadsheet detailing the quotes. While Century Link is the most
 attractive Todd Dawson has asked for contracts to review to make sure we are getting
 what they are quoting. As a side, the quote information was sent to Dan Linton (an
 expert in the field) and he has taken his time to provide us with his comments and
 suggestions.
 - In light of the quotes received and our past history with Comcast and its service quality, Todd Dawson moved to send Comcast the official notice that Sunset will not be renewing its services with them upon expiration on April 1, 2020. Per the contract the notice needs to be sent by the end of December. Steve Walz seconded the motion. The motion carried.
 - An email is in preparation to explain the direction and options regarding cable to our owners.

Stairway project – We received the report from our engineer that indicated some of the
pans and doors to the stairway needed repair and replacement. The next phase of the
project is underway which involves the engineer soliciting quotes from vendors to
complete the repairs. Lloyd Shroyer is in contact with the engineering firm, and will
keep the Board updated.

Owner Comments: No comments were received from the owners.

With no further topics to be brought before the Board, Todd Dawson moved, and Lloyd Shroyer seconded a motion to adjourn the meeting. Motion carried.
